Improvements to include crack seal, asphalt patch, sealcoat, replacement of parking blocks, striping and replace concrete trench drain. **TIME AND PLACE OF BID OPENING:** Bids will be received until 2:30 p.m. (local time) on the **9<sup>th</sup> day of May, 2018** in the Department of Engineering and Planning, 9768 Airport Boulevard, Mascoutah, IL 62258, located at MidAmerica St. Louis Airport. Each bid must be submitted in accordance with all submission requirements set forth in the bidding documents. Facsimile submittals are not acceptable. **Late proposals will not be accepted.** Questions must be directed in writing as detailed in the Instructions to Bidders.

**WAGE RATES:** CONTRACTORS shall be required to pay not less than the prevailing wage rates on the project as established by the State of Illinois, Department of Labor.

**CONTRACT SECURITY:** The Bidder to whom a Contract is awarded shall be required to furnish both a Performance Bond and Payment Bond for 100% of the Contract Price for each of the above Bonds, in accordance with the requirements of the Contract Documents.
